Traveling to Hawaii

All individuals traveling to Hawaii MUST complete the mandatory state of Hawaii travel and health form located at the link below before arriving to Hawaii and **be sure to apply for quarantine exemption**. In order to apply for the quarantine exemption, you must upload your vaccination record document to the Safe Travels portal and bring your vaccination card with you , you must have a hard copy in hand when arriving in Hawaii. If this information is not completed it will be mandatory that the traveler quarantines for 10 days when they arrive.

All international travelers/non-U.S. citizens traveling directly to Hawaii must present BOTH a vaccination record AND a negative COVID-19 test result (NAAT or antigen) within one day of boarding a flight to the U.S. The airlines will screen passengers prior to their departure to the United States. International passengers entering the U.S. from another state or territory will be treated as domestic travelers when entering the State of Hawaii. *Attendees should closely review all current requirements needed for travel to the Hawaiian Islands from your place of origin and airline.

As a reminder, you will need to log back in and take the Health Questionnaire 24hr prior to departing your place of origin.


